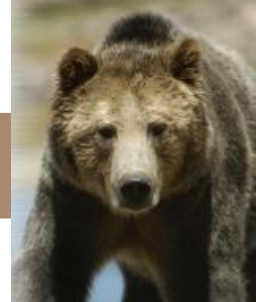


Premiere Concrete Remover

Removes unwanted concrete from trucks, tools, chutes, and other surfaces.

Premiere Concrete Remover can be diluted at all levels in water and can be sprayed over surfaces. Laboratory evaluation is recommended to ensure proper application levels and compatibility with other chemicals.

Uses for **Premiere Concrete Remover** range from pH adjustment of all types of aqueous solutions, to dissolving water insoluble salts including CaCO₃, soap scum residues, and other insolubles, to cleaning pre-coat filters, pressure filters, dregs filters, evaporators, heat exchangers, liquor heaters, digesters, and boilers.
